CIRCULAR

In pursuance of the Federal Government's directives vide SRO No. 1885(I)/2025 dated 23rd September, 2025, Vessel Management and Operations covering port call requests, vessel registrations, vessel intimation reports, mandatory FAL Forms 1-7, port clearance processes and associated payments etc. shall be transitioned from the current manual processes to the PCS platform for all the **Non-containerized Maritime Terminals** located in the jurisdiction of Port Qasim Authority and Karachi Port Trust. Accordingly, all related services in the WeBOC system shall also be discontinued w.e.f. 15.01.2026.

3. Shipping agents, and other stakeholders are required to use the PCS platform for issuance and processing of requisite regulatory compliances and payments thereof without exception.
